- 7. Prices communicated to client are in accordance with price provided by the operator. Clients will be informed of any price changes which are beyond the direct or indirect control of Astra Travel.
- 8. Astra Travel is only an agent of the relevant operator in respect of the services rendered and has no control over the fact whether the operator makes himself guilty of overbooking and/or overselling.
- 9. In the event of you declining travel insurance, despite our advise to take same out, Astra Travel will not accept any liability for any damages/loss incurred as a result thereof. You will be required to sign an indemnity in this regard.
- 10. Any changes required by the client subsequent to bookings being made, will be subject to any administrative and/or cancellation fees as recovered/raised by the operator, for which the client will be held liable.
- 11. Astra Travel accepts the following methods of payments cash, bank cheques and credit cards.
